



DAY 1

CAIRO TO AMMAN, MADABA, MOUNT NEBO, AND PETRA Upon your morning arrival in Amman, you'll be met at Queen Alia International Airport. Begin your journey in Madaba, home to exquisite Byzantine mosaics, including a 6th-century map of the Holy Land. Continue to Mount Nebo for breathtaking views of the Jordan Valley and Dead Sea, where tradition says Moses viewed the Promised Land. Travel on to Petra, the ancient Nabatean city. Check in, enjoy dinner, and spend the night in Petra. Optional Petra by Night tours run on Monday, Wednesday, and Thursday evenings.



After breakfast, explore Petra, the new wonder of the world. This city, was carved in stone more than 2,000 years ago to dominate the trade routes of ancient Arabia. Visit its towns, dams, and water channels. First, walk the Siq, a narrow path of three-quarters of a mile, which is the main entrance to the city. At the end of the Siq, you will see the Treasury ("Khazneh"), believed to hold countless treasures. The first view of the Khazneh is breathtaking. Later, drive southeast to Wadi Rum, known as the Valley of the Moon. Enjoy dinner and an overnight stay in a Wadi Rum desert camp.

WADI RUM TO THE DEAD SEA After breakfast, visit Wadi Rum, a uniquely shaped massive mountain rising among the rosy red sand of the desert with towering cliffs of various brownish, reddish, and golden colors.
